Market Commentary

- JCI end at their day's low, erasing 55 points on Tuesday amidst volatile trading as sentiments remain fragile with the dollar and treasury yields rose ahead of key economic data later this week.
- JCI opened lower while selling pressures intensify in the second session led by tech and digital banking stocks along with telcos, and Energy stocks amid volatile movement.
- Almost all sectors closed lower with Tech stocks contributing most to index declines. While some Consumer cyclical stocks remain elevated.
- RUPIAH +0.29% at 15,358 against USD.
- Tech stocks along with digital banking stocks suffered the most, as the prospects of aggressive rate hikes rattled the sector sentiments. GOTO $\rm IJ$ 5.79%, BUKA $\rm IJ$ -1.48%, WIRG $\rm IJ$ -6.59%, ARTO $\rm IJ$ -6.54%, AGRO $\rm IJ$ -3.33%.
- Energy-related and metals were mixed and mostly lower at the close, erasing early session gains on short-lived trading. ADRO IJ +0.26%, PTBA IJ +1.69%, HRUM IJ -2.54%, PGAS IJ -1.37%, MEDC IJ -1.52%.
- BUMI IJ -6.82%, ends at their day's low amid volatile trading after getting shareholder approval for private placement. The Co. will issue 200bn of Series C shares at 120 rupiahs each.
- Top value were: BUMI IJ -6.82%, BBRI IJ +1.37% IJ, BBCA IJ -0.60%
- Top Gainers: BBRI (+1.37%), BRPT (+4.43%), CPIN (+1.84%)
- Top Losers: GOTO (-5.79%), TLKM (-2.49%), ARTO (-6.54%)

- EAST Recorded 9M22 net profit of IDR20bn, 4.1x yoy. (Kontan)
- PGAS Signed MoU with JRPT to expand gas network in residential area Bintaro Jaya and Graha Raya, with potential customers of 35,000 house connections. (Kontan)
